

A Plea for Repentance, That Healing May Come!

There is an issue I need to make people aware of. It would be ever so nice to ignore it and try to continue living life in blissful ignorance, but quite frankly the Lord wants the issue dealt with and has given me the commission and the anointing to deal with it, and part of the commissioning has to do with what amounts to an Ezekiel 33: 1-5 directive—as in, I am directed to be a watchman and make you aware of issues that pop up that have the potential to suppress the witness or the effectiveness of the Body of Christ, and ask you to participate in the process of dealing with those issues so that people are not deluded or rendered ineffective in their Christian walk.

So...what is the problem that inspires this letter, you ask? There are Ephesians 6 principalities and powers that have taken up residence in Maine, but in particular have centered their stronghold in Aroostook County. Those evil entities are being allowed to stay by permission of the people who reside in The County due to **ignorance** that the problem even exists; and the **resultant lack of action** on the part of the churches to deal with the problem.

Just a note in CONFIRMATION: the essence of this article was confirmed just this past August 1, 2019 by a preacher speaking at the annual camp meeting at the Whited Bible Camp in Bridgewater, Maine. This preacher was from LOUISIANA, and had arrived at the camp only twenty minutes before he was to preach because he had flown into Portland Maine which was six hours away instead of the Presque Isle airport (which is only 20 minutes away) and had to drive hours up to the Bible Camp. He hadn't had time to talk to anyone about the County's "Issues" and had no prior knowledge of the issue of the "Pillar of Wickedness" in the County but was speaking from the inspiration of the Holy Spirit. The dozen or so pastors from "The County" that were there at the meeting had all gotten the early developing copies of this article from me by the Postal Service mail TWICE over the past five months, and when the Louisiana preacher spoke at length in his sermon about AROOSTOOK COUNTY having a particularly bad problem with a "Jezebel spirit" the pastors thought of me and this article. The confirmation by the Louisiana preacher is KEY in getting the point across that there is a REAL PROBLEM with P&P's and demons in "The County" and God wants us to take it seriously..."knuckle down"...and DEAL WITH THE PROBLEM!!

There are those denominations or Christian groups that are well experienced in dealing with issues relating to demonic possession or activity, but ALL OF CHRISTENDOM is called to be commissioned and empowered to not only **"go into all the world and preach the gospel to every creature"** but also **"these signs shall follow those that believe...in MY NAME they shall cast out demons..."** (Mark 16:15, 17).

Aroostook County, either by the lifestyles, or choices and activities they have freely/willingly engaged in, and actions taken over its history have given these principalities and powers legal permission to attach themselves to The County, affecting the lives of the people therein, suppressing holiness with their activity; and only an acceptable degree of 2 Chronicles 7:14 repentance in the hearts of a sufficient number of people will move the hand of God to deliver us out of the situation.

Aroostook County is (in land mass) the largest county east of the Mississippi River, as large as the States of Massachusetts, Rhode Island, and part of Connecticut combined, but unlike the number of

persons in that three state area, (nearly 20 million people); in Aroostook County as of 2019 there are only 64,000. It is an area of vast resources, gold and copper, farmland, deep forests for lumber, moose, bear and deer huge in body size and numbers. If you move to Aroostook County, you would be well advised to own a gun, drive a 4-wheel drive vehicle, and after you get here, make sure to insulate your house for Alaska-type weather due to the recent start of the coldest part of the 200 year weather cycle.

You of course could rightfully ask “so what gives you the idea that there are principalities and powers controlling our region? I have four stories I can tell. The first story that sets the stage involves a lady and her husband from Aroostook County (I won’t reveal exactly where) that went to the Northern European nation of Sweden for a vacation about 12 years ago. While visiting there, they went to church on a Sunday night, and that particular week there was a traveling evangelist speaking at the church who said that an unusual occurrence had happened to him the previous week: he had been given a vision by the Lord. He said that in the vision he had seen a map of the United States, and there was a veil of wickedness over the entire country, and that veil was held up/sustained by three powerful pillars of wickedness. It seems that then the traveling evangelist said “Does anybody know...is there such a place called ‘Aroostook County?’” Purportedly the lady sitting in the congregation that was from Aroostook County couldn’t believe her ears, and indicated that SHE was from Aroostook County! The evangelist then said “Of the three pillars of wickedness, the one in Aroostook County is the most powerful, and if you pray and succeed in taking down that pillar, the other two will fall, and wickedness will be defeated in the United States.” (The other two “pillars” are in Oregon and Florida.)

The second aspect of the situation concerning wickedness in the County is this: I went to Iceland back in 2003 to be trained by a scientist who developed a new method of artificial insemination of sheep. The Lord told me that while I was there, I would be attacked TWICE spiritually. Those attacks did indeed happen, and a couple years later (late 2005), the person (a high level satan-worshipping warlock) responsible for directing the demons to attack me in Iceland moved to Aroostook County from Southern New England, and opened a shop a couple hundred yards south of me in Presque Isle where my jewelry store and repair facility was located at the time. I had just finished an Elijah-like assignment by the Lord to pray for the weather for 42 months, and it is possible that the Holy Spirit may have been still resting on me heavily enough for the warlock’s “spirit guides” to be worried about it and considered me to be a big enough threat to order this warlock to Aroostook County to counter my prayer efforts as well as to shut down the revival that was on the brink of breaking out at the large church I was involved with (which the warlock succeeded in doing). If indeed Aroostook County is an exceptionally powerful and important stronghold of wickedness, this would have been a promotion for him. Those who are scrupulously obedient in the assignments given them by Satan are rewarded with more authority and power. Keep in mind, we are not talking about “every day garden variety” wickedness. Serious and dedicated Satan worshippers hold as many as seven celebrations/religious services per month and these “celebrations” even include kidnapping of persons to torture and sacrifice. In that month of seven celebrations in particular, five of the celebrations include the coven leader (and others) having sex with boys, women, babies and animals, usually with bloodletting, cutting the bones out while the victim is alive, and then eating the flesh.

By the way, one of the men involved with that church’s men’s prayer meeting that had covered me in prayer while I was in Iceland and in which the revival was developing; became indignant that the warlock had moved to Aroostook County, and told several of the pastors of that church that he was

going to take some anointing oil and go to the warlock's place of business, anoint the sidewalk and walls of the building and pray against him. The pastors all told him they didn't feel that was wise to do in this case, but he refused to listen and he did it anyway. Two weeks later, a moose walked in front of his car, my friend hit it and died. (His error was that he engaged in a PRE-EMPTIVE and unprovoked attack upon the warlock and his spirit guides, AND in addition, he did it without the permission and prayer covering of the pastors OR the men's church prayer group.) My friend might have been safe if he was only dealing with mere demons, but it is likely the warlock was "covered" by upper level "Principalities and Powers" (fallen angels from 2nd heaven). Prophet John Paul Jackson¹ says, you don't PREEMPTIVELY attack upper level P&P's, you ask GOD to do it. (An example of going to God like this is found in Dan 9:)

When a DEMON [which is a lower-level earth-born evil entity] attacks YOU first, or manifests/acts up in front of you, or is oppressing someone, you *without question* have the authority given you in Christ to bind it and cast it out. "The seventy" of Luke 10:17 who had not even been anointed yet by the Holy Spirit at Pentecost were given authority over demons. Demons are evil spirits of EARTHLY origin (see the addendum to this article), but upper level principalities and powers are ANGELS that rebelled against God, were kicked out of third heaven and confined to earth and 2nd heaven, and until we know and are instructed differently, it would be wise to deal with P&P's in an entirely different way. (It is possible the "demon" in Mark 9:29 may have been a fallen angel, not a demon, for according to Jesus, it would only come out with prayer).

Until we know differently, with upper-level P&P's, it seems the SAFEST way to go about it is to 1.) Humble yourself and repent of your own sinfulness, and 2.) Ask GOD THE FATHER to help MANY people to become aware of the problem and lay it on their hearts to repent and pray, (in a case involving an exceptionally powerful entity ruling over a large area, YOU DO IT IN AGREEMENT WITH MANY OTHERS IN PRAYER!)...then ask God the Father to send His holy warring angels and His Holy Spirit to deal with the evil entities, in effect, IF MANY of you humble yourselves and turn from YOUR wicked ways; God hears from Heaven, and HEALS THE LAND in a true 2 Chronicles 7:14 procedure.

Anyway...when this warlock arrived in Aroostook County, the various problems that were a reality back in 2005 suddenly ramped up dramatically. The number of witch covens increased, as well as the drug problems, child abuse and sex trafficking especially (as well as many other serious issues).

The third reason I know there is a particular problem in Aroostook County is that March 17, 2019 I went to southern New England to visit my daughter. While there I had two solid days of prayer and non-canonized scripture reading of the testimonies of the Patriarchs from Enosh (the third from Adam) through Aaron that had been found among the Dead Sea Scrolls. During that time there were very few minor spiritual attacks and only light/insignificant opposition even though the warlock's influence and the coven structure set up by him would still be active in that area of southern New England even with the warlock not being there; but in the two days I was there, I had many strong visitations by the Lord's Holy Spirit (12 to 15?), and the supper time Tuesday night was truly anointed! Tears all around the table (the GUYS started crying FIRST, BEFORE THE LADIES!)

My wife and I left my daughter's house at 3:30 AM Wednesday March 20, 2019 and when we were just outside the city of Boston, (at 5:30AM) I said to the Lord, "since I have been away from Aroostook County for three days, I might be more sensitive to spiritual activity there, so why don't I ask

You, Lord, to give me a sense as to whether there REALLY IS still a powerful “pillar of wickedness” in “The County” that needs to be dealt with!” (I prayed this ABSOLUTELY SILENTLY, my lips didn’t move or ANYTHING...not even quietly whispering the prayer, giving no sign whatsoever that would tip off a demon that I was praying AT ALL, and I also did not tell my wife so if any “evil entity” was listening in from afar, [which they are OFTEN doing], they would not be “clued in.”)

I forgot about the prayer until four hours later when I started feeling a little “off.” I asked my wife for a cup of coffee and a half slice of lemon cake to see if ten minutes later the strange feeling would have stopped. THEN I would know for sure if it was my metabolism or LOW BLOOD SUGAR that I was feeling and NOT the beginning of a spiritual attack. But 10-12 minutes later, it was obvious that my metabolism WASN’T the problem, it WAS a spiritual attack that was developing, and guess where I was at that time (even though I didn’t know it at the moment)... just outside the border of Aroostook County!! The “feelings” I had started having 10 minutes earlier were indeed Ephesians 6 principalities and powers gathering their forces to mount an attack on me!!

I felt the forces continuing to strengthen, and I told my wife why I had asked for the coffee and lemon cake slice, and told her what I had prayed just outside Boston. I then felt the assault start to wind up, and in response I said in a very ominous tone, “THE WARRIOR SPIRIT IS RISING IN ME!!!” Then an instant later IT HIT FULL FORCE, and my wife said it was like two Greek titans RUSHING AT EACH OTHER to engage in armed warfare WITH SWORDS AND BATTLE AXES! I BELLOWED AT THE TOP OF MY VOICE, “THE LORD REBUKE YOU...I COMMAND YOU TO BE BOUND IN JESUS’ NAME” and I let out a powerful and loud growl characteristic of a combatant rushing to engage his foe. (My wife was totally taken by surprise by the drama and suddenness of all this...imagine her dismay!!)

I cried loud groans of anguish with the effort, and shouted at the top of my lungs to the Lord to defend me. I REFUSED TO BE OVERCOME AND I FOUGHT BACK WITH EVERYTHING WITHIN ME. (At this time I was driving down the road at 75 mph, which was the speed limit at that section of the highway. THANK GOD HE WAS KEEPING MY HANDS ON THE STEERING WHEEL AND KEEPING IT STRAIGHT! The evil spirit probably figured it might be able to “take me out” by causing me to crash the car!)

When the attack had eased up, I cried and prayed and praised the Lord and immediately started praying for my wife, my children and grandchildren as we continued to drive down the road, that the Lord would cover and protect them.

The incredible power of the attack and the effort I had to put out to fight back and resist took an enormous amount of adrenaline, and I was weak and shaky for a couple days afterward, and I was prone to gritting my teeth and trying to hold back the tears. It was actually a whole week before I felt completely myself again. This was one of the four most serious attacks I have experienced over the last 48 years, and of the four, this one took the most out of me!

I had merely asked God to give me A SENSE of whether there was a problem with Principalities and Powers in Aroostook County, but God answered by allowing a full blown attack...probably to impress me with the severity of the problem! There IS INDEED a principality and power resident and active in Aroostook County, Maine, and it knows what we (the Aroostook Prayer Network) are doing to oppose it, and you can bet it will be gathering it’s resources to attack again, so be forewarned! (It DID try again, read this FOURTH story!)

The fourth proof of a problem with P&P’s and demons here in Aroostook County was an attempt by the P&P’S to scare me away from dealing any further with the issue by assigning an

enforcer/assassin to pay me a visit. Not only have the Principalities and Powers been made nervous and uncomfortable by our prayer efforts which have since gone national, they seem to be nervous enough to make the effort to “keep an eye on us,” because the only way the enforcer/assassin could know to say to me the things he did would have either been by eavesdropping through telecommunications and spy techniques, or by demons and P&P’s actually listening in to our prayer and discussion times and giving that knowledge to this assassin to prep him for this intimidation assignment. There would be no reason to do that if our knowledge was off base, or if our prayers were ineffective. (More detail on this assassin’s visit later in this essay).

I would advise you all to SERIOUSLY PRAY, REPENT, AND BEG THE LORD FOR AN INCREASED EMPOWERMENT TO STAND, BECAUSE IT IS OBVIOUS THAT THE BATTLE IS ON, AND I FOR ONE AM ALL IN UNTIL EITHER VICTORY OR DEATH...and I know that because the LORD has an agenda, and because I am going to be careful to do all things PROPERLY, and BECAUSE OF JESUS’ ANOINTING, I/WE WILL BE VICTORIOUS!! I HAVE NO FEAR!! WHEN THE LORD SPECIFICALLY PREPARES A PERSON, CALLS YOU, ARMS YOU, ANOINTS YOU FOR THE BATTLE, THEN as a teaching exercise HELPS YOU THROUGH ONE, THE EXPERIENCE SOLIDIFIES YOUR COMMITMENT TO HIM AND YOU ARE PREPARED AND THERE IS NO FEAR OF THE NEXT BATTLE!! It also serves to galvanize you in purpose, and help you to be more aware of the need to CONSISTANTLY be walking in the POWER OF THE HOLY SPIRIT and asking for help to live a “clean” life that is pleasing to Him. You will be more diligent in your walk because you realize that to “stumble” or to not be diligent could provide a little loophole that the evil spirits or P&P’s would use as an opportunity to attack you or your family, and you can rest assured...IF YOU ARE WALKING IN RIGHTEOUSNESS, the “enemy” is INDEED watching you!

So...how do we deal with this situation? WE HAVE TO CHANGE A SUFFICIENT NUMBER OF PEOPLE’S MINDS as to THE SIN THAT IS GOING ON AROUND THEM, AND THAT THEY ARE USED TO TOLERATING AND LIVING UNDER. The reason a principality and power takes up residence in an area is because NOT ENOUGH people DISAGREE with its being there.

Pastors need to lead their congregations to the place where they understand that “praying the prayer” of salvation then going out and living like the Devil is not acceptable. The Holy Spirit has been given and the empowerment to live in Righteousness is available to us. When we submit to God and WILLFULLY ACCEPT His empowering gifts, the following can become true in our lives: **“We know that whoever is born of God does not keep on sinning! But whoever has been born of God guards himself, and the Wicked One cannot touch him!” (1 John 5:18)** Those who are truly saved will **“Take every thought captive to obey Christ...”** (2 Cor 10:5 ESV)

With this letter we are hoping that MANY pastors on a LARGE SCALE will lead their congregations to the place where great numbers become willing to pray and honestly repent of actions and desires that God is not pleased with, and bring their people to the place where they can ask God to empower them to **‘walk not according to the flesh but according to the Spirit’** (Rom 8:4), helping their congregations to knowledgably repent and ask for empowerment to walk consistently in Righteousness.

In his book *Expelling Darkness*, Russ Dizdar, a world-known expert in deliverance ministry, made a statement that agrees with what the Lord has shown me; that to continue to IGNORE these problems is to EMPOWER THEM. If we decide NOT to deal with the presence of the evil spirits, the problems will get even stronger/worse, and the grip of the P&P’s on the area and on people’s minds and hearts will get even more powerful because of the TACIT PERMISSION granted to the principalities and powers or

rulers of darkness by our NON ACTION. (Dizdar, Russ; **EXPPELLING DARKNESS, page 108**)

A story to serves as an example of what I am calling for is told by Dr. Lance Wallnau of an incident that happened while he was pastoring a church in one of the southern New England states. While Dr. Wallnau was ministering in a church gathering, a demon screamed its displeasure at the fact that there was a religious gathering in the building that it was used to occupying. The Holy Spirit was manifesting in the meeting, and the demon didn't like it one bit! The demon was not inside any person and not using anyone's voice to express itself; it used its own voice and screamed its displeasure, sounding like an angry Lynx or a Bobcat.

When another travelling evangelist was asked what his thoughts were on the matter, the evangelist said "If there is a demon in the building, it is because there are *a sufficient number of people who have AGREEMENT with it to allow it to be there!*" [The solution is to] "declare a solemn assembly and come together in agreement to break that spirit" (which the church did successfully). The problem was presented to the congregation; they humbled themselves, repented, fasted and prayed for a week previously, then came together in a "solemn assembly" and bound the demon and ordered it to leave. A week later, a group of people who were an ongoing problem in the church up and left as well!

The problem was dealt with when ENOUGH people were willing to RISE TO A SUFFICIENT LEVEL OF INTERCESSION AND REPENTANCE. In Dr. Wallnau's situation they were merely dealing with a demon.... "principalities and powers" and "rulers of darkness" are much more tenacious, powerful, and difficult to deal with, but, IF A SUFFICIENT NUMBER OF PEOPLE become aware of the problem and are WILLING TO REPENT OF *THEIR SINS AND HUMBLE THEMSELVES AND PRAY AND SEEK GOD'S FACE, AND TURN FROM THEIR WICKED WAYS*, GOD WILL HEAR FROM HEAVEN AND WILL REMOVE/DISEMPOWER THAT EVIL ENTITY, and will HEAL THEIR LAND!! But as opposed to a mere demon; it is wise for us to request that *upper level evil entities be removed by God Himself, which He would move to do if ENOUGH people learn what is displeasing Him, and repent on a broad enough scale.*

If God responded to just one or two or maybe FIVE or even SEVEN people's requests for an evil entity to be removed (which is a good STARTING POINT), the REST of the people would continue on in ignorance, taking their improved conditions for granted, not even knowing an evil entity had been removed (or ignorant of the fact that there even WAS an evil entity!) There likely would have been no challenge issued to the ordinary churchgoer concerning particular issues, their sin patterns and everyday failures would not have come under question, no-one would have come under conviction concerning their sins, therefore there would be essentially NO REPENTANCE. Because of that, even if God DID answer the prayer of the 2 or 3 people, due to the ignorance and lack of repentance on the part of the many, eventually the P&P would return, probably with seven others more wicked than itself, and the city or region in question would end up in an even worse condition than before!² But NOW I have even more information which has been discovered which justifies the call for many MANY to be involved in prayer! There are more LAYERS to the problem! As in, there are the three powerful "pillars" (principalities) at the top, but there are MANY "middle power" principalities distributed throughout the country, and then at the "bottom rung of the ladder" are HORDES of demons which make up the "veil of darkness" being sustained by the 3 pillars as described in the vision of the evangelist from Sweden.

Credit has to go to Pamela of New Jersey who is in the deliverance ministry, and Melinda of

Florida who told me of her experience of being “caught up” in the Lord and shown a vision of America, with a map stretched out before her like in the vision of the travelling evangelist from Sweden, but instead of seeing three pillars, she observed many little black dots all over the map, with some areas having a higher concentration of dots than others. She asked the angel that was with her what the black dots were, and he said “those are what you are fighting against.” She asked me what I thought the little black dots meant, and I responded with the following: “This past week I asked the Lord to heighten my sensitivity under the 1 Corinthians 12 Holy Spirit gift of Discernment, so I could drive through some towns in Aroostook County to gauge the degree of oppression in each individual town, AND also stop and pray at the various churches along the way, to see if the Holy Spirit is resting upon any of them. I was shocked at the results. (Assume a scale of 0 through 10, zero being NO OPPRESSION, and 10 being SEVERE oppression). The results of travelling through to gauge the oppression in each town went this way: Town #1, 6; ...town#2, 4; town #3, 2; town #4, 2; town #5, 4+; town #6, 1; town #7, 4+; town #8, 2; town #9, 7 (WOW!); town #10, 2; town #11, 2; town # 12, 1. Note the towns that are underlined because the oppression is substantially higher than the others? Those towns would be “black dots” on the map of the U.S. that Melinda saw and would be under the control of a greater number of minor principalities and powers, and demons.

Pamela from New Jersey told me that Atlantic City, New Jersey has such a powerful pall of darkness over it that even NON-CHRISTIANS can discern it!! THAT entity is probably an Ephesians 6 “Ruler of Darkness” or a middle level “power” which I am calling “black clouds” for the purpose of this discussion. (By the way, of the **forty churches** I passed on this little trip, **only 7** had a discernable Presence of the Lord abiding on them!!!) So what we seem to be dealing with is: a broad spectrum hierarchy of wickedness extending from the top-level principalities and powers down to the bottom rung demons, imps, and ideas that exalt themselves against God. So now, for the complete picture: Imagine a map of the United States stretched out before you. On it you notice three thick black columns shaped like the Tower of Babel--like in paintings you may have seen. The biggest/most powerful pillar is planted firmly on the upper half of the State of **Maine**. The second one is found rooted in Oregon, and the third one is in Florida. Elsewhere on this map are a couple dozen or more smaller “black clouds,” most of them over high population areas like Atlantic City New Jersey, New York City, or Los Angeles. Then lastly you see lots and lots of little black dots representing towns distributed unevenly across this map.

The little “black dots” are towns that have an unusually high degree of wickedness being practiced by the town’s residents participating in demonic activities. The dozen-plus “black clouds” are cities with the highest numbers of humans whole-heartedly pursuing wickedness and providing structures and supply chains of victims to be acted on by people cravenly lusting to carry out wicked actions; and at the most potent and powerful top level, the three pillars or columns are used continually by the most powerful agents of the “Detestable Fallen Archangel,” who ascend the “staircase” to “second heaven” to plan out or receive the next assignments to be carried out by the most wicked members of humanity, and instructions to be given to the lesser entities of corruption inhabiting the black clouds and dots. The total number of Ephesians 6 evil entities arrayed against us is huge. Remember the demoniac in Mark 5:9 whose name was “Legion” because there were so many? A Roman legion is comprised of 6000 soldiers. That is how many demons were in THAT ONE MAN!!! A NATIONAL PRAYER EFFORT is needed on our part! If we take up the task, it will go nationwide!

It has now been 3 months since I first asked the Lord to increase my sensitivity under His gift of Discernment, and about ten weeks since I alerted a nationwide prayer organization concerning this “pillar problem.” When the national prayer partners first started praying, the “pillar” and “black dots” seemed to dig in to resist being overcome while the number of people praying for Maine around the nation was small. Early on also, the “pillar” & “black dots and flyspecs” (“flyspecs” = house/property sized areas of strong oppression) were likely bolstered by the witch’s and celtic neo-pagan’s prayers and rituals which are part of the world-wide celebration of “Beltane” (Tuesday April 30-May 1st) which marks the “first day of summer” and the start of the growing season. Right after “Beltane,” instead of the “wall of oppression” starting at a town line, this occult activity by the witches pushed the wall of oppression even further out from each town, and the *intensity* of the oppression also became even more severe.

This continued for a week, but was then enhanced in the next week to an even greater degree by three events: **1.)** The passage of 4 anti-God laws by the Maine Legislature; **2.)** witches around the whole world gathering to pray and celebrate the “New Moon” May 6th (when the moon is completely dark), and **3.)** on that night as well, 2 professing Christians in Aroostook County committed suicide, which would have strengthened the P&P’s considerably! The “wall of oppression” around each town grew even larger and was sustained at that high level of intensity for two days. BUT THEN, I have to assume the strength of the Christian’s prayers nation-wide for Aroostook County had grown in numbers and power to the extent that on Thursday morning May 9th, I awoke with a wonderful sense of peace, release and joy. The dark power of the P&P over Aroostook County seemed defeated (over MY house anyway). As I discerned each town’s level of oppression on my travel to work that day, the oppression level in each town was dramatically reduced. In Presque Isle (which previously had an oppression level of “7”), the intensity was decidedly reduced, (to a “4”?) even though the “wall of oppression” still began three miles from the border of the town. However, there were some small areas which had been previously indistinguishable from the general level of intensity, but now were so powerful that it was as if I were *slapped* by the impact of the oppression as I approached them (I’m calling the small areas “fly-specs” as opposed to whole towns [black dots]). I asked the Lord about it, and He let me know that due to the increased number of prayers for Aroostook County by the Saints across the nation, great chaos was being experienced in the ranks of the demons and fallen angels. Despite their “drinking in” of bad legislation, witch’s prayers & the deaths of 2 Christians, the wicked spirits were starting to “lose their grip” and were abandoning their normal “homes” & congregating where they felt most welcomed, and in those spots, the concentration of demons was so great, driving a car through it felt like a slap.

Also, as of May 20, it seems that the oppression has weakened even further due in part to a prolonged and intense battle in which my son and I had to engage an evil entity. There is a certain place on Rte 95 in Maine which harbors a demon or evil entity which has attacked me eight times out of ten when I have travelled by. (The FIRST time was the horrendous attack I described earlier in this letter). As my son and I were returning home from a wonderful prayer time in Waterville, I slowed the car when I was still 12 miles from that now infamous spot, so that if we were attacked again, it would be less likely to drive us off the road. An attack did indeed start, and TEN MILES BEFORE the usual place! My son and I immediately started praying against the evil entity, reminding it that we were under the call and protection of the Lord, and that it needed to “back off!” We claimed Jesus as our Savior and Lord and reminded the evil entity that we were bought by the atonement that Jesus paid for with His own blood that we had freely accepted for ourselves. We told the evil entity that we would NOT submit EVEN

UNTO DEATH!!! The pressure and weight of oppression was very strong. It was very evident that it wanted complete access to us, but we were protected by the Lord and His holy angels. We did not know it, but at home my wife had woken up with a sense that we were in trouble and was praying for a vanguard of angels to surround the car as we drove. Hands also had been laid on us at the prayer time in Waterville that night and prayers had been offered to God requesting added and ongoing protection for us in our assignment of “taking down the three pillars,” and it was evident that those prayers were being answered. The attacks from this evil entity lasted for 66 miles! At Houlton, Maine, the attempts to get at us finally stopped. The effects during the attack were a heaviness, with tunnel vision and a threat of fainting and a queasy stomach...so in reality, it was indeed physical, but not to the extent we were being “twisted into a pretzel” or our throats being choked to shut off our air (which is common). But the after-effect of this attack, due to our resistance through Christ, is that the next day, (May 21, 2019) the oppression hanging over the whole County was reduced even further. The “wall of oppression” that usually started as much as six miles before the Presque Isle town line was no longer there, and at some spots along the way, the presence of the Holy Spirit and His joy were so strong, I burst into tears and cried and rejoiced almost all the rest of the way to work. Did we turn a corner? Will this condition remain? It did not, but we are making headway. The need to repent and come together for corporate prayer and stand against oppression does not stop with one victory. Oppression still remains over most of “The County,” the people still need to be informed, the minds of the people still need to be changed, and they still need to come to be willing to gather in corporate prayer to repent and pray and receive empowerment to walk in righteousness on a CONTINUAL BASIS to have a hope of long lasting victory!!

It would be helpful here to point something out; demons and principalities and powers feed on and are sustained or strengthened by human suffering and the shedding of blood, especially CHRISTIAN blood. At their various rituals (which they celebrate an average of 3-4 times per month!), wicked spirits and evil humans torture innocent children for the purpose of producing adrenochrome in the tortured child’s blood which Satan worshippers then drink at their ceremonies, giving a drug-like high as well as increased power and higher placement in Satan’s authority structure. With adults and teens, demons feed off rage, depression, the intensity of lust, great sorrow or the shedding of blood, and fear. Remember Jesus CONSTANTLY said “FEAR NOT?” He said that in part to help us be protected against demonic oppression. Demons feed on fear, and hang around people who tend to be fearful. We however are to live in and act upon the knowledge that **“the weapons of our warfare are not carnal but mighty in God for pulling down strongholds...casting down arguments and every high thing that exalts itself against the knowledge of God”** (2 Cor. 10: 4, 5 NKJV). And further, we the church need to be mindful to take up again and apply the directive given to Jeremiah in Jer 1:10: **“...I have this day set thee over the nations and over the kingdoms, to root out and to pull down, to destroy and to throw down, [but also] to build, and to plant!”**

It is likely that the spirit P&P’s of Aroostook County may have come under enough prayer pressure and gotten desperate enough due to the increasing prayers of the Saints to where they sought out three unsuspecting Christian families the night of May 6th (the “New Moon”) in order to feed and strengthen themselves by discouraging the souls of the two Christian men, causing them to take their own lives, one by travelling to a “high place” of evil where he stabbed himself in the heart, and the other (though Christian, and of a well known, highly respected and truly Christian family) had a substance addiction problem, and died that very same night (May 6th) as well, causing much grief and sorrow. The

first man was a respected Christian man, a regular churchgoer, taking his life for no known reason. I have to assume there was a personal issue or weakness of some sort that the 'devil' could capitalize on in order to overwhelm him with oppression. "That can happen to a real Christian?" you ask. YES, and you would do well to listen to at least the first ten minutes of a video by the highly respected Christian teacher named Derek Prince, who had a teaching and deliverance ministry for 60 years before he died (around the year 2003). THIS IS *IMPORTANT!* Go to: www.youtube.com/watch?v=ZNp6DNQOOL0

After asking the Lord about it, it seemed that after I alerted other prayer teams around the nation to the problem of the 3 pillars, what likely happened is that the new and increased prayer support at that time affected the P&P's to the extent that it caused "chaos in the devil's camp" and the P&P's started to lose their grip and struck out in desperation when witches gather on the night of the "New Moon" (5/6/19) in an attempt to sustain themselves by "drinking in" the blood and sorrow of the Christian families that were affected by the deaths of these men that night. But their strengthening was short lived. On the third day after, (Thursday May 9th) the power of the P&P's was discernibly weaker.

Keep in mind, THREE men that we know of have been killed by this P&P.

- 1.) The man who *preemptively* prayed against the P&P's covering the warlock (mentioned on page 2) and was then killed by the moose in late 2005:
- 2.) The second man's suicide by knife in the heart May 6th:
- 3.) the death of the addicted Christian young man May 6th;

but also: 4.) AN ATTEMPT was made during that SAME period of time (May 6th) on one of the seven men who meet to pray in OUR OWN group on Thursday nights to seriously discourage his soul, but he is tough and experienced in the Lord, and resisted the attempt for several days. When I discerned what was going on with him, we defended him in prayer and the P&P's stopped harassing him (AND he is now definitely RE-energized in doing the Lord's work!)

These effects on three of the four men happened WITHOUT us praying against the P&P's DIRECTLY. Can you see how a PRE-EMPTIVE attack DIRECTLY against P&P's like we of Charismatic background used to do in decades past can potentially be so dangerous? Notice if you will that it has been an intense two month battle by MANY people across the nation which has been effective in reducing the power of this P&P, NOT a quick and simple one time declarative prayer of two or three people, (even though 2 or 3 is the NORMAL procedure sanctioned by the Lord Jesus in usual circumstances). Also remember we are dealing with "Princes" (Principalities) over nations and regions like in Daniel 10:12, 13, in which even the archangel Michael did not rail against the Prince of Persia, but said "the LORD rebuke you!!" YOU certainly do NOT have greater standing than MICHAEL, so YOU shouldn't rail against P&P's either...go to God in company with many others and ask HIM to bind them!!

Note that my group of seven Holy Spirit anointed men have been praying for two years about this problem and seeing little results, supporting my belief that in a situation like this, just a few people "doesn't cut it." The Lord wants many **MANY** PEOPLE TO HUMBLE THEMSELVES AND REPENT, **"THEN will I hear from heaven and heal their land"** (by binding the P&P's). Also, GOD IS LOOKING FOR BROAD SCALE AND *SUSTAINED* REPENTANCE THROUGHOUT THE NATION!!! "The County" is just the beginning!!

Now back to the fourth story that gives a clue as to how serious the situation in Aroostook County MAY be. You remember that on page 4, I mentioned a visit by an enforcer/assassin who works for/does the bidding of Satan, and was likely given the assignment to intimidate me or "take me out."

Russ Dizdar, a world-known deliverance minister calls these "Jason Bourne" type persons "Super

Soldiers”... specially trained men and women who have willingly been run through a process to suppress or kill their own soul and implant multiple demons in them, with each of the demons having a certain “skill-set” which is triggered by a “code word” specific to that type of mission and the specific demon-type who would carry it out (i.e. assassination, injury, sexual seduction, etc.).

While this “Super Soldier” was trying to intimidate me and trick me into repeating the “code word” which would trigger the demon and start the attack upon me (which he attempted SIX TIMES); he made a revealing statement which proved that his visit was indeed of satanic origin, because NO-ONE outside the prayer team of seven men was told that my prayer group was researching a specific Indian tribe that had resided in Maine for thousands of years and likely in its distant past had interaction with the Phoenicians and Egyptians. No-one could have known that we had discovered that unless we were being monitored by the use of high tech spy technology, or by the eavesdropping of demons or P&P’S. Without my having touched on the topic WHATSOEVER, or mentioning anything concerning the research we had done on the Indian tribe, this Super Soldier said “the _____” (the Aroostook County Indian tribe) are ‘with us’ as well.” Probably for the purpose of intimidating me, this “Super Soldier” had just finished naming some people and organizations in our area that were in league with Satan and that I was surrounded by, and this Indian Tribe was the last one mentioned. Without hesitation I asked him “why did they (that Indian tribe) adopt the Egyptian Hieroglyphic writing?” Without having to pause to think about it, he said “because they wanted to interact with their ancestors.” I asked “just how far back in time were these ancestors?” Again, immediately and without hesitation he said “from the time before Adam and Eve.”

Because I had made absolutely NO PREVIOUS MENTION of this Indian tribe in the conversation with this Super Soldier, it was made very evident that the upper level principalities and powers are indeed watching us, listening in, and aware of what my prayer group is doing....that we are praying against them and standing in opposition to their ‘rule’ over us here in “The County” as well as nationally.

That Indian tribe we had researched had contact with the Phoenicians and Egyptians in ancient times (possibly even before the time of King Solomon), and the proof of that was that this tribe (from Maine, Nova Scotia, and New Brunswick, Canada) had adopted the Egyptian hieroglyphic writing back in ancient times. The Phoenicians and the Egyptians would have brought their “gods” and idols with them on their sea voyages for protection, empowerment and guidance, and this Indian tribe was impressed with it to the extent that they embraced and practiced it all, so we may be dealing here in Aroostook County with the spiritual compatriots of Dagon, Molech, Ba’al and Anubis, all of which are particularly ancient and powerful, (and zealous to protect “their turf”). The Super Soldier didn’t contradict any of this information, but confirmed it all, and then this information was all confirmed to me AGAIN the very next week by another person I had never seen before who was one of the members of that Indian tribe. To my knowledge, never has a member of that tribe ever been in my store, but this person who walked in a week after the Super Soldier’s visit was one who had *even participated* in the rituals that “call up” the “spirits of the dead,” as well as in ceremonies to call up “the Little People” (wood fairies, imps, lesser demons, elf-like creatures, and libertine Bacchus-type orgy-inducing spirits etc.).

What was notable about this person was that she was obviously inhabited by demons, which I could discern as soon as she walked in the door and before she even said a word to me, which is evidence that she had indeed been participating in ceremonies to call up the “dead ancestors” and interact with wood fairies, Bacchus-type demons, etc.

This Indian tribe has been duped over the several millennia into believing that they have been interacting with their actual ancestors, but in fact had been consorting with fallen angels who have *misrepresented* themselves as their ancestors so “they” could exert influence over them and not be detected. If the Super Soldier was being honest about this tribe having interacted with “Pre-Adamic” beings, then it is indeed probable that at least SOME of the evil entities that are presuming to rule us here in Aroostook County are upper-level PRINCIPALITIES and POWERS which have “left their former estate” [heaven] (Jude 6), and embraced Aroostook County as their new “home” after leaving Egypt and Phoenicia, which confirms the decision to be cautious by employing 2 Chronicles 7:14 repentance, and asking GOD to dis-empower and remove their influence FOR US, rather than treating the angels like lower level demons which we have “all authority” given us to bind and cast out. (See a discussion about demons and their origin and why they are different than P&P’S in the Addendum to this essay.)

Previous to these unusual visits by the Super Soldier and the Indian lady a week later; it was suggested by someone in the deliverance ministry as well as someone else who had earned a Doctorate in Theology, that I plot the coordinates of four famous sites of ancient evil known in the world today that are thought to be “portals” used by P&P’S and demons, to see if they line up with Aroostook County, which would give us a clue as to whether Aroostook County ITSELF had become a “portal” or “highway” for evil entities to use to travel back and forth from earth to 2nd heaven.

The well known centers of ancient wickedness that I plotted the coordinates of were the famous **Tower of Babel**: 36° 40’ North, 40° 65’ East; **Mount Hermon**: 33° 24’ 58” N, 35° 51’ 27”E (where 200 angels made a pact to “hang together” and defy God when He called them to account for their deeds...see the non-canonized, extra-biblical book of Enoch, chapters 6 and 7); the famous **Stonehenge**: 51° 10’ 44” N, 1° 49’ 34” West; and the **Serpent Mound** near Peebles, Ohio which is at: 40° N, 84° W.

Placing a globe of the world in your lap, when you stretch a string from the Serpent Mound over to Stonehenge, and then over to Mount Hermon (where angels descended to start “taking” the pre-Flood women as per Genesis 6 which I discuss in the “Addendum”), and then over to where it is thought THE TOWER OF BABEL was located, amazingly enough, Aroostook County falls squarely on that line!! To those who are expert in spiritual mapping for the purpose of knowing how to pray against principalities of a particular region, this is significant and speaks to the likelihood that Aroostook County is indeed the location of an actual portal used by evil entities, and if we choose to *IGNORE* the problem, the P&P’s will be strengthened and encouraged and THINGS WILL CERTAINLY GET WORSE!!!

Why would they get worse, you ask? Because the following truth would likely be applied (Matthew 16:19 KJV): “...**whatsoever you shall bind on earth will be bound in heaven, and whatsoever you loose on earth will be loosed in heaven.**” Or...let’s say it this way: “**whatever you SHOULD BIND on earth but DON’T because of your ignorance or inattention or spiritual laziness, your non-action will be observed by the Lord, and He may say “OK...I can see you are NOT being diligent to BIND things that SHOULD be bound down there on earth, so I’ll just FOLD MY ARMS UP HERE IN HEAVEN and let you EXPERIENCE THE CONSEQUENCES of your spiritual laziness until you realize your error and come to me in repentance, THEN I will hear from heaven and HEAL your LAND!”**

Honestly, IF AFTER KNOWING there is a problem with powerful principalities and powers in Aroostook County, if we do nothing, or an INSUFFICIENT number of pastors and people take the issue seriously, I believe the Lord will allow MULTIPLE DIFFICULTIES to befall Aroostook County like the Lord would occasionally bring against Jerusalem. ..What do I feel could come to pass if we do nothing?

“When you spread out your hands in prayer, I will hide my eyes from you, even though you multiply your prayers, I will not listen.” (Isaiah 1:15) and “Jeremiah, don’t pray for this people or beg me to rescue them...if you do, I won’t be listening when they call out to me in their disaster!” (Jeremiah 11:14). “I will do this because they have not listened to my words,” declares the Lord, “which I sent to them time and time again by my prophets...” (Jeremiah 29:19)

So...what do I suggest you do? First of all, you yourself go before God and pray, be honest and acknowledge the problems YOU PERSONALLY are struggling with, repenting and asking for the gift of the Holy Spirit, and a special gift of help to more effectively stand against temptation, and to receive instruction from God as to what to do. Then: get “evangelistic” in your efforts to alert the prayer warriors in your church concerning the “3 Pillar Problem” and encourage them to do as YOU have done (repent), and prepare to join with other churches in a “solemn assembly” like what Lance Wallnau’s church did to corporately cry out to God.

THEREFORE LET US WORK TOGETHER AND STRIVE TOWARD THAT END!!!**

ADDENDUM: THE ORIGIN OF GIANTS AND DEMONS: Giants are the CHILDREN of the 200 fallen angels who “kept not their first estate” (Jude 6 KJV) but saw that the daughters of men were beautiful and descended to Mt. Hermon in Phoenicia, made a pact to defy God and “took to themselves wives of all they chose” (Genesis 6:2 and Enoch chapters 6 and 7). “There were giants in the earth in those days...when the sons of God came in to the daughters of men, and they bore children to them.... (Genesis 6:4 KJV) As punishment, God’s curse upon the sinful actions of the fallen angels in Genesis 6 was spelled out in detail in the ancient extra-biblical book of Enoch chapter 14: 4-7, in which Enoch is bringing the angels who sinned an answer from God pertaining to their question of whether God would forgive them for what they had done, which was to “leave their first estate” and “defile themselves with women.”

Why do I dare mention the book of Enoch in this essay? Because Jesus Himself calls it “Scripture.” In Matthew 22, verses 23-30; Jesus quotes from the Book of Enoch chapter 15 in answering the Sadducees about the woman with seven husbands...which one of the seven will be her husband when “we-all” get to heaven? Jesus said to the Sadducees that “Ye do not know the scriptures OR the power of God...” The removal of the book of Enoch, (which the early Church relied on heavily) takes away the *only* reference in all the 87 books of canonized and uncanonized scripture that Jesus quotes from that addresses the issue Jesus is commenting on!! Enoch chapter 15, which Jesus refers to with His answer to the Sadducees states essentially that in heaven there is no marriage, because the beings that are there are eternal, whereas the humans in physical form on earth are not eternal...they die, therefore they need to be able to reproduce in order for the earth to continue to be populated. Either the Sadducees didn’t read every scripture that was available to them, or they deliberately feigned ignorance to see how Jesus would answer the “conundrum” they had presented to Him. Note again that Jesus (as well as Paul) referred to the Book of Enoch as “scripture.” The Book of Enoch is decidedly Messianic in its theology rather than Jewish. Enoch had encountered the pre-incarnate Jesus at least several times while in Heaven and mentioned Him many times in his writings, calling Him “The Elect One who would redeem us,” and “the Son of Man” which was Jesus’ favorite name for Himself. Note also the fact that the early church Fathers and the Laity read the Book of Enoch and relied on it *extensively*.

In 2nd Peter 2:4-5, the Apostle Peter also uses a phrase which is found nowhere but in the Book of Enoch (Enoch 19:2), talking about the angels that sinned, that they were “delivered into chains of darkness, to be reserved unto judgment.” Jude verses 14 and 15 quote from Enoch 2:1. Many of the key concepts Jesus spoke about are directly connected to terms and ideas found originally in the book of Enoch. Over 100 phrases in the New Testament find their origin in Enoch. Fragments of 10 Enoch manuscripts were found in the Dead Sea Scrolls found in the Qumran caves. It was considered scripture by many early followers of Jesus, as well as by 2nd and 3rd century “Church Fathers” such as Justin Martyr, Irenaeus, Origen, and Clement. Tertullian (160-230AD) called the Book of Enoch “Holy Scripture,” and the Ethiopic Church added the Book of Enoch to its official canon.³ And, as previously mentioned, Jesus referred to Enoch as “scripture.”

God’s answer through Enoch concerning the petition for forgiveness requested by the 200

angels was: **“your petition will not be granted unto you throughout all of eternity. Your judgment is final. The decree is: from this point on you will be bound on earth throughout all the days of the world. You will not be able to reenter heaven. But before you are bound, you will see all your loved ones (their children, the giants) destroyed. You will not be able to possess them; you will only be able to watch them fall by the sword. Your petition on their behalf, or for yourselves, will not be granted, even though you weep and pray...”**

Then in Enoch 15: 3-7, which Jesus referred to in Matthew 22:29-30 and Luke 20: 34-36: **“Why have you left the eternal heaven, and lain with women and defiled yourselves with the daughters of men by taking them as wives, like the children of earth do, and begotten giants as your sons? Although you were holy, spiritual, living an eternal life, you have defiled yourselves with the blood of women, and have begotten children with the blood of flesh, and have lusted after flesh and blood as the children of men do who die and perish. This is why I gave them wives, that they might beget children by them, so that nothing may be wanting to them on earth. But you were formerly spiritual, immortal for all generations of the world, which is why I DID NOT appoint wives for you, for spiritual beings have HEAVEN as their dwelling!”**

In Enoch 15: 8-12, God said concerning the *children* of the fallen angels: **“My judgment for the giants is that since they are born from flesh, they will be called “evil Spirits” and will remain on the earth. Because they were created from above (from the holy Watchers), at death their spirits will come forth from their bodies and dwell on the earth. They will be called evil spirits. The heavenly spirits will dwell in heaven, but the terrestrial spirits who were born on earth will dwell on earth. The evil spirits of the giants will be like clouds. They will afflict, corrupt, tempt, battle, work destruction on the earth, and do evil; they will not eat nor drink, but be invisible. They will rise up against the children of men and against the women, because they have proceeded from them.”**⁴

It is not my goal here to prove the validity of the book of Enoch, which is canonized and contained in the Ethiopic Bible and called “scripture” by Jesus and Paul, but is nonetheless extra biblical and should be used with care and discernment...The use of Enoch in this essay is to inform you as to the origin of demons and their characteristic actions, and the fact that Principalities and Powers are ANGELS, not DEMONS, as well as to remind you that in Matthew 10:1 and Luke 9:1, Jesus sent out the disciples and gave them power to bind and cast out DEMONS: He mentions nothing about battling against, binding, or casting out fallen ANGELS; therefore UNTIL WE ARE LED BY THE LORD TO DO OTHERWISE, **AND ARE VERY SURE AS TO WHAT IS THE PROPER WAY TO DEAL WITH P&P’S** (and Mark 9:29 may be a clue), IT SEEMS THAT THE WISE COURSE WOULD BE FOR US TO GO THE 2 CHRONICLES 7:14 ROUTE, due to the fact that P&P’S occupy a region because the majority of people don’t object; or in fact may even feel quite COMFORTABLE with their being there.
